- Landlord Referral Reference (page 3)
- Proof of employment: 2 months worth of pay stubs. (If you are transferring please provide your transfer letter) / If self employed: 2 months of bank statements and 2 years tax returns
- Copy of your U.S. Government Issued photo ID for each Adult (18+) occupant.
- List of any other occupants (Children and Adults) with Names and Ages
- Fill out Pet application at sahuaritagreenvalleyrentals.petscreening.com No Pet(s): \$0 (You must still fill out a Pet Application, even if you do not have one.)
- Email all required documentation to <u>documents@southwesternrealtyusa.com</u> as <u>PDF attachments</u>.
